Argentina has received a loan from the International Bank for Reconstruction and Development to finance the cost of the Development Project of Provincial Public Health Insurance and intends to apply part of the funds from these loans to payments under the Contract "Acquisition of Medical Equipment for New Treatments" LPI No. PHIP -LPI -3 -B -8.

International Financing Unit of Health invites eligible bidders to submit sealed bids for the purchase of medical equipment for New Treatments, according to the following details: Lot 1: Syringe Infusion Pump, quantity: 350; Lot 2: Multipurpose Color Doppler Ultrasound with 4 transducers, quantity: 49; Lot 3: Oxygen Mixer (Blender), quantity: 100; Lot 4.1 Fetal Monitor, quantity: 37; Lot 4.2: Multiparameter Monitor, quantity: 126; Lot 5: oxygen saturation meter, quantity: 42; Lot 6: Respirators high complexity, quantity: 80; Lot 7: Fluid Heater, quantity: 50.

Bidding will be conducted through the international competitive bidding procedures (ICB) procedures specified in the World Bank 's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from eligible source countries as defined in these rules.

Qualifications requirements include: (a) Average annual income: The amount of average annual sales turnover in the past 3 years must be at least equivalent to 7 times the value of the offer. (b) Experience and Technical Capacity i) installed capacity of production: the bidder or the manufacturer, in the event that the bidder is not the manufacturer should have an installed annual average production capacity equivalent to at least the following amounts: Lot 1: Pumps Infusion syringe 3150 units; Lot 2: Multipurpose Color Doppler Ultrasound with 4, 441 units, lot 3: Oxygen Mixer (Blender), 900 units; Lot 4.1: 1 Fetal Monitor, 333 units; Lot 4.2: Multiparameter Monitor, 1134 units; Lot 5: oxygen saturation meter, 378 units, lot 6: Highly Complex Respirators, 720 units; Lot 7: Fluid Heater, 450 units; ii) Number of similar contracts executed: The bidder shall have fully implemented at least 3 similar contracts to this tender during the last 2 years. It's understood as similar contracts those in which the object is to offer goods in amounts at least equal to the Bid request. iii) Experience: The Bidder must demonstrate that they have manufactured and / or marketed the specific goods offered for a period of not less than 2 years. Specific goods means those goods offered in this tender regardless of brand or model.

A margin of preference shall be given to goods manufactured in the Purchaser's country. Further details are provided in the Bidding Documents.
