Böylece firmalardan gelecek teklifler 19 Eylül 2016 tarihine kadar kabul edilecektir. İmtiyaz sözleşmesi kapsamına 2.367.517 metre karelik havalimanı alanı girmektedir. Havaalanının işletme haklarını devralan şirket, 16.791.000 Euro'su (KDV hariç) ilk beş yılda olmak üzere, toplamda 35.267.000 Euro'dan az olmamak üzere (KDV hariç) yatırım yapma yükümlülüğünü de üstlenmiş olacaktır.

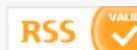

Has liabilities for public debts to the state or municipality by implication of Art. 162, para 2 of the Tax Insurance Procedure Code, established by act of a the competent authority that has become effective unless rescheduling or deferral of debts or public debts is allowed to the state where it is established - for a participant who is a foreign body;
 - 1.3. Has outstanding debts to the workers and employees whom the participant is an employer;
 - 1.4. Has already been a Concessionaire and the concession contract was terminated due to its fault;
 - 1.5. It is its fault for professional misconduct, for which the Commission has written evidences issued by a competent authority;
 - 1.6. It has not provided the whole information required by the participants in the procedure for concession granting or the information provided is incomplete or incorrect.
2. When participating in this procedure for granting of concession, the participants shall submit statements for the availability or lack of the circumstances under item 1.1 – 1.5 according to the forms – Attachments No 13 and 13a. When the participant is a legal entity, the person with representation powers according to its registration shall sign the statement.
3. The Commission with motivated decision shall establish the circumstances under item 1.6.
4. Prior the contract conclusion the participant granted as a Concessionaire shall submit evidences for certifying the circumstances stated under item 1, set forth in Art. 41, para 2, item 1, 2 and 4 of the Regulation on the Application of the Concessions Act. The concession contract shall be concluded only after the participant granted as a Concessionaire has performed his obligation under this item.

5. When the participant is a union – the documents under item 2 and item 4 shall be submitted by each member of the union.
6. When the participant has pointed out subcontractors in his offer the requirements of this Section shall be applied for the subcontractors too.
7. During the procedure the participants shall be obligated to notify the Commission for all changes occurring in the circumstances under Art. 16, para 4 of the Concessions Act within 7 days as of their occurrence.

17. Selection Criteria and Documents providing the Compliance with these Criteria:

17.1. Competency to perform professional activity:

Requirements and required documents:

17.2. Economic and financial standing:

Requirements and required documents:

The criterion "Economic and financial standing" includes:

1. Registered fixed capital of the Participant or at least of one of the Consortium members, when the Participant is a Consortium not less than 1 000 000 (one million) BGN.

Documents of proof:

One or more documents proving the amount of the Participant's registered fixed capital.

2. Amount of carrying and/or market value of the long-term fixed assets of the Participant or of at least one members of the Consortium, when the Participant is a Consortium, used for activities involving management and operation of an airport in the last 3 (three) financial years, not less than 20 000 000 (twenty million) Euro, defined as the arithmetic average balance value of fixed assets.

Documents of proof:

The annual financial statement and/or with the respective market-based valuation prepared by licenced valuator for the last 3 (three) financial years, accompanied by the respective audit reports and reports by the managing body. Should the legislation of the respective country of the Participant's address of management require it, an auditor should verify the submitted annual financial reports. The Participant with a statement shall prove the absence of audit requirement by the respective legislation.

When a foreign participant proves the criterion, the BGN equivalent shall be calculated using the exchange rate of the relevant currency announced by the Bulgarian National Bank for 31 December of the year of the respective annual financial statement, by which the compliance with the criterion is justified. In case the Bulgarian National Bank does not announce the exchange rate of participant's currency with respect to BGN, the BGN equivalent shall be calculated according to the exchange rate of the respective currency against the BGN for the respective date as announced by OANDA Corporation - <http://www.oanda.com/currency/converter/>.

17.3. Technical capabilities and/or professional qualification:

Requirements and required documents:

The criterion "Technical capabilities and/or professional qualification" includes:

1. Participant's experience, or experience of at least one member of the Consortium in case the participant is a Consortium, of at least 5 (five) years in the period of the last 10 (ten) years of performing activities, similar to the services covered by the concession scope and particularly with the operation and management of an international airport with not less than 1 000 000 (one million) passengers per year and/or cargo not less than 40 000 (forty thousand) tons per year.

Documents of proof:

a) certified copies of licenses/certificates/registrations, contracts or other documents as per the national legislation of the Participant, establishing the Participant's eligibility for activities concerning management and operation of an international airport with passenger transfers not less than 1 000 000 (one million) passengers per year and/or cargo transfer of at least 40 000 (forty thousand) tons per year, specifically activities of airport operator and ground service of such airport. In case this activity is not subject of Participant's license or registration in the respective state, this fact and the right of the Participant to perform the relevant activities shall be declared by the representative of the Participant;

b) Statement by the legal representative of the Participant, confirming the existence of circumstances under this item 1, containing completed or currently performed during not less than 5 (five) in the last 10 (ten) years of activity in management and operation of an international airport, as well as information about documents confirming the authorization to perform the activity of airport operator and on-ground operator of an international airport with passenger traffic at least 1 000 000 (one million) passengers per year and/or cargo traffic of at least 40 000 (forty thousand) tons per year (licenses, certificates, contracts or other in conformity with the national legislation of the participant) and this information shall contain at least the document number, the state of issuance and the period of performance of the activity, and, as far as contracts are concerned - the scope, date of conclusion, period of validity and the respective parties.

2. Possession by a Participant or member of the Consortium of technique and technical equipment - its own or hired - to ensure the efficient performance of all activities related to the management and operation of airports and on-ground service as per Art. 48, para 3, item 2-7 of the CAA and for ensuring the compliance with the established standards and procedures for safety and security of flights as per Art. 48g, para 2, item 4 of the CAA.

The requirements to normal functioning of a civil airport for public use, including individual systems and facilities, as well as organization and technical plans are set in Regulation No. 20 of the Ministry of Transport dd. 2006 for certification of the operation compatibility of civil airports, airfields, systems and facilities of ground service, for licensing of airport and on-ground service operators and access to the on-ground service in airports (promulgated in SG # 101 dd. 2006, as amended in SG #26 dd. 07.04.2015) - standards for use of facilities and operations concerning the ground handling service of aircrafts (Regulation No. 20).

Documents of proof:

Description of the proposal by the Participant for technology and equipment to cover the requirements for obtaining licenses for airport and ground handling operator with respect to all activities under item 1.3.1 of Resolution of the Council of Ministers No. 244 dd. 4 April 2016 and in compliance with the established standards and procedures for safety and security of flights as per Art. 48g, para. 2, item 4 of the CAA, indicating the reasons of its use - ownership, contract or other document confirming engagements of the Participant to provide the service.

3. Availability of qualified technical personnel (experts and managers), including those who will be responsible for the operation of the airport, having the required qualification, professional experience and practice in airport operator engagement as per Art. 48r, para 2, item 3 of the Civil Aviation Act and for performance of the ground handling operations as per Art. 48d, para 3. items 2-7 of the CAA.

The persons mentioned in this item shall also comply with the respective requirements stated in Regulation 20.

Documents of proof:

- list of the technical persons, including those who will be responsible for the operation of the airport]
- list, CVs and documents certifying the degree and professional qualification of the expert and managing personnel who will be responsible for implementation of the Concession contract, establishing the conformity with the requirements of this item.

In the case of a union:

1. The members of the union should meet criterion “Technical capabilities and/or professional qualification” as a whole;
2. The members of the union should meet the criterion “Economic and financial standing” as a whole ;
3. With respect to the criteria under items 1 and 2 each member of the union should explicitly point out what part of them is proving.
4. In case of granting the concession to a participant in the procedure, that has applied as a union which is not a legal entity, the concession shall be granted to a newly established equity commercial company registered under the Commercial Act of the Republic of Bulgaria or entity registered as a trader according to the legislation of the member state of the EU, or another state which is a part under the Agreement for the European Economic Area in which company the members of the union possess the whole capital in the ratio according to their union agreement, and the members should keep their percent share in the capital of the Concessionaire, as well as voting rights in the general assembly of the Concessionaire and the control in its management during the entire period of the concession, except for the explicit written consent by the Concession grantor.

The criteria for complex evaluation of offers and their relative weighting are:

1. Size of the annual concession payment with relative weighting of 40 percent;
2. Investment program with relative weighting of 35 percent;
3. Program for development and management of the concession object with relative weighting of 25 percent, including at least proposals concerning a business model for development of the concession object; provisions for the traffic during the concession period; concept for development of the airport infrastructure; organization structure; management of airport operations; safety management; security management; investments management; commercial management; social program; environmental program.
