2016 Eurasian Week will be held on 26-28th of October, on the margins of the Russian Annual Open Innovations Forum at the Skolkovo Innovation Center, Moscow.

Following the theme of the event “EAEU in the global innovation agenda” the Forum will unite tech entrepreneurs.

The Forum agenda will include the following topics:

- Eurasian technological platforms development,
- Union’s single market formation,
